No Sena or MVA leader is supporting Sanjay Raut: Shelar

MUMBAI, FEB 11 --/ BJP leader Ashish Shelar on Friday claimed that Shiv Sena MP Sanjay Raut is not finding any support within either his own party or the Maha Vikas Aghadi (MVA) coalition government in Maharashtra.

Speaking to reporters here, Shelar, a former state minister, said, "Raut is isolated within the MVA government." Raut, a Rajya Sabha member, had alleged two days ago that central agencies were "systematically targeting" Shiv Sena leaders. "It seems no leader of the MVA is going to help him.

It could be the reason behind Raut making such huge noise after the Enforcement Directorate started grilling him in some cases," Shelar said. Raut had been "defaming the BJP" for the last seven years but ED officials were not conducting any probe against him during this period, he said. (PTI)

Gurugram building collapse: Builder Chintels India to conduct structural audit of project

NEW DELHI, FEB 11 --/ A day after partial collapse of its residential tower in Gurugram killed two people, realty firm Chintels India on Friday said the company is cooperating with the local authorities on the "unfortunate" incident and would conduct a structural audit of the entire project.

The incident happened at 'Chintels Paradiso' project at Sector 109, Gurugram in Haryana. Police have booked the builder and the construction contractor for negligence while the district administration has ordered an inquiry into the matter, according to officials. "This is an

extremely unfortunate incident and we have taken it very seriously as the safety of our residents is our utmost concern. Upon preliminary investigations, we have come to know that the mishap occurred during renovation work by a contractor being carried out by a resident in his apartment," Chintels India Managing Director Prashant Solomon said in a tweet. According to him, the company had conducted a structural audit last year in the wake of complaints regarding the project. "We will be initiating a second structural audit at the earliest. In case any defects are found in the structure,

we will duly compensate affected buyers or accommodate affected residents in alternate arrangements while necessary repair work is completed," Solomon said.

He also said the company is fully cooperating with the authorities and ensuring all support, "... we will do our best to ensure that such incidents are not repeated in future. (PTI)

Yemeni man held for getting rifle parts manufactured in Gujarat

AHMEDABAD, FEB 11 --/ A 36-year-old Yemeni national was arrested with parts of AK-47 and other assault rifles, which he allegedly got manufactured from engineering firms in Gujarat, police said on Friday. Based on a tip-off, the Ahmedabad crime branch nabbed the accused Abdul Aziz Al-Azzani from a hotel on February 9, and seized parts of assault rifles from him, an official said. The police recovered a gas block, a front sight, a short



barrel and some other mechanical parts of various assault rifles, including AK-47, he said. The crime branch also recovered nearly 150 wax moulds and four dyes from two firms in Kathwada area of the GIDC in Ahmedabad, the official said. According to the police, Abdul Aziz had planned to send these rifle parts to Yemen, a war-torn country where groups such as the Al-Qaeda and Houthi rebels are fighting against each other. Preliminary

investigations have revealed that the accused, who is a resident of Al-Baidah city in Yemen, works as a labourer and farmer, the official said. To fulfil the demand for parts of assault rifles in Yemen, one Munir Mohammed had offered commission to Abdul Aziz to acquire these parts from India and send them to Yemen, the crime branch stated in a release.

Abdul Aziz had visited Mumbai in 2018 for his father's heart operation, and

had since visited every year for his father's check-ups, it said. As per the deal struck with Munir, Abdul came to Mumbai with his father on November 16 last year, and after a check-up, he sent his father back to Yemen and travelled to Ahmedabad, it was stated. The accused contacted D K Engineering, a firm in Odhav GIDC area, to prepare dyes for parts, such as a short barrel, front sight and gas block, the release said. (PTI)
